




# Global Overview

SK On and Hyundai Motor Group are [investing \\$5 billion](#) through a joint venture for EV battery cell production in Georgia.

### Tennessee

SK On is expanding its U.S. battery manufacturing capabilities with a facility outside of Memphis.

### New York

[Key Capture Energy](#), part of SK Innovation E&S, develops and builds large-scale battery energy storage systems.

### Oklahoma

SK Innovation E&S and Continental Resources have a long-standing joint development agreement for domestic U.S. shale gas.
